

# A Message from the BOARD CHAIR & EXECUTIVE DIRECTOR

The past year has been exceptionally challenging for the child welfare sector, and our agency has not been immune to these pressures. We have faced significant financial constraints, served families with complex needs, and grappled with the shortage of essential services, such as residential placements. These challenges underscore the urgent need for a comprehensive overhaul of the social service system to better support children, youth, and families in our community.

Despite these obstacles, we are immensely proud of our dedicated staff and their unwavering commitment to the children and families we serve. Their hard work and dedication have been instrumental in achieving positive outcomes through our collaborative efforts with community partners, stakeholders, and service providers.

#### **PROGRESS**

#### Strategic Priorities and Achievements:

In alignment with our mission to protect and promote the well-being of children and youth, we have focused on our strategic priorities. Our staff have been committed to ensuring we practice through a lens of cultural humility and competency, working alongside families we serve to reduce issues of overrepresentation in our priority populations. We are pleased to report significant progress in this area.

#### CHILD PROTECTION AND FAMILY SUPPORT:

Our dedicated staff have worked tirelessly to ensure that every child in our care receives the necessary services and resources. We supported 3501 families, with a focus on keeping families together in the community and reducing the number of children that require alternative formal care with us.

#### Community Partnerships and Collaboration:

Our collaborative work with community partners like the City of Windsor, New Beginnings and the Windsor Essex Community Housing Corporation, has been impactful. Together, we've ensured enhanced services and supports for our Ready, Set, Go (RSG) Youth Program through the Crawford Supportive Housing Initiative. In addition, our partnership with the Maryvale Children's Mental Health Treatment Centre is underway to assist youth with complex needs in finding viable solutions to best support their needs.

#### EQUITY, DIVERSITY, and Inclusion (EDI):

We have implemented several Equity, Diversity and Inclusion (EDI) initiatives, including staff training, policy reviews, and community outreach efforts. These are crucial to ensuring that our services are inclusive and accessible to all members of our community. We held events recognizing our priority populations, such as celebrating Black History Month with the Black African Caribbean Canadian (BACC) community and acknowledging the various Nations we serve during Indigenous Peoples Day and the National Day for Truth and Reconciliation. We also hosted an Iftar Dinner in celebration of Ramadan and held our own Pride flag raising ceremony during Pride Month alongside community partners and allies of the 2SLGBTQIA+ community and more!

#### **CHALLENGES**

#### Funding Constraints:

Like many not-for-profit organizations, we are experiencing funding challenges, which have impacted our ability to expand programs and services. We continue to advocate for increased funding and investments to meet the growing needs of our community.

# Increased Demand For Services For Children and Youth with complex needs:

In the wake of the unparalleled demand for mental health/complex needs and family support, our agency

has seen a surge in families in our community seeking help that the child welfare system just can't fulfill alone. Our dedicated staff are working tirelessly to address the demand, but it's clear that more support is desperately needed.

#### Staffing and Workforce Development:

Attracting and retaining top talent remains a challenge. We are committed to creating a supportive work environment that fosters professional growth and development.

#### Financial Overview:

Our financial position remains precarious, but our commitment to prudent fiscal management has allowed us to allocate resources efficiently for maximum impact. The current community context and demands for service have placed immense pressure on our budget, but we remain dedicated to serving those in need.

#### **FOCUSING ON THE FUTURE**

#### Enhancing Service Delivery:

We will continue to explore innovative ways to deliver services more effectively, including leveraging technology and data to improve outcomes for children and families.

#### STRENGTHENING COMMUNITY TIES:

Building stronger connections with our community

partners will remain a priority, ensuring that we can provide comprehensive support to those in need.

#### Advocacy and Public Awareness:

We are committed to advocating for policy changes and increased funding to better serve our community. Raising public awareness about the importance of child welfare will also be a priority.

In closing, we would like to express our sincere gratitude to our Board of Directors, staff, volunteers, foster/ kin caregivers, and community partners for their commitment and support. Your dedication and passion for our mission make a difference in the lives of the children and families we serve every day. Together, we are making a positive impact in the Windsor-Essex community.

NATIONAL DAY FOR AWARENESS OF MISSING & MURDERED INDIGENOUS WOMEN, GIRLS & TWO-SPIRIT PEOPLE (MMIWG2S+) - On May 5, 2023, WECAS acknowledged MMIWG2S+ Day through a virtual all staff meeting. RED dresses were displayed outside the building to signify the importance of recognizing the violence that Indigenous Women, Girls and Two Spirit People continue to endure. (1)

GOURMET GARDENS 2023 - WECAF's signature event, Gourmet Gardens, was held on Sunday, May 7th at Sprucewood Shores Estate Winery.

WE R HERE, WECAS BOARDROOM MURAL PROJECT - In partnership with Art Windsor Essex (AWE) and local artist Talysha Bujold-Abu, WECAS hosted a series of art workshops which culminated in a mural in WECAS's Boardroom that is inspired by community and designed by muralist Julie Hall. (2)

WECAS ALL-STAFF MEETING & APPRECIATION BBQ – On June 12th, WECAS hosted an all-staff meeting and Staff Appreciation BBQ.

**PRIDE RECOGNITION CEREMONY** - Our agency held a Pride Recognition Ceremony on Thursday, August 3rd in recognition of Pride Month 2023 and to affirm WECAS' ongoing commitment and solidarity to the 2SLGBTQIA+ community. The theme for this year's ceremony was 'Becoming the Affirming Community that Children & Youth Need'. (3)
